


## Positive results for Sheffield City Region

Sheffield City Region's small and medium sized enterprises (SMEs) are reporting positive results despite the economic challenges and Brexit uncertainties.

Profits generated by this year's Top 100 SMEs stand at an impressive £185m, up from £157m last year. The businesses have seen an 18 per cent increase in profit before tax, together with a 12 per cent increase in turnover and four per cent increase in headcount.

Barnsley - based Glass Recycling (UK) has climbed to number one in the table with an impressive increase in profits from £1.8m to £5.1m. This growth is no doubt built on businesses and public sector organisations being more environmentally aware and Glass Recycling (UK) investing in new machinery to improve the removal of unwanted materials from the glass it collects.

The annual table welcomes 36 new entrants this year, the highest being the Tours Abroad Group, who saw an increase in profits from £0.4m to £3.4m. The Tours Abroad Group includes the Leger and Sunway brands and offers escorted holidays across the world.

New entrants have contributed £52m to the overall profits and 3,100 employees, with the service sector being dominant, accounting for 67 per cent and 56 per cent respectively.

Of the 36 companies which dropped out of the table this year, 17 were as a result of decreasing profitability and five as a result of growth which has taken them into the large company status. This certainly reflects a mixed picture in

the economy where some industries are faring better than others.

Reflecting on this further, the retail sector which is only a small percentage of our overall regional economy at 5%, was the only sector to experience a decline in the year. Profits had fallen from £12m to £9.2m. The service sector continues to dominate the local and national economy and this year has shown impressive growth in profits from £82m to £101m. This represents 54% of the total profit generated in the SCR in 2019.

Overall, the results indicate a positive trend for the SCR with profits, turnover and headcount all increasing despite a backdrop of Brexit uncertainties and a challenging economic environment. SMEs continue to contribute significantly to the local and national economy and should be at the forefront of the Chancellor's mind when he delivers his next Budget (to be confirmed!) to ensure the backbone of the economy can flourish.



# Planning for a successful business sale

### Deciding to sell a business is one of the most important decisions a business owner will make.

For most it is about more than just realising the financial gains from years of grit, determination and dedication – an important factor for many is finding a good home for the business where both the company and its employees can continue to flourish.

Every deal is of course different and needs to be handled in its own unique way, however there are common mistakes that should be avoided.

#### Little or no preparation

The earlier preparations start, the easier it is to identify and fix issues. Working with advisors a few years in advance can help to not only maximise interest in the business and the value of the offers received, but also reduce the risk of value leakage during due diligence or a deal failing to complete altogether.

#### No exit plan

#### **Maintaining trading performance**

Selling a business is both time consuming and immensely distracting, particularly for the senior members of the management team involved, and it is not uncommon to see trading suffer. A sales process is about building confidence in the company and its future, so it is important to maintain this focus as far as possible and minimise the impact that a process can have on trading results.

#### Find a great advisor

Selling a company is an intense and often complex process and there is a huge amount of skill in ensuring a deal gets over the line. It is vital you find an advisor who is able to delicately manage the numerous negotiations and commercial points which will inevitably arise. Do not underestimate the importance of working with someone who is not only experienced at identifying and extracting the highest offers for your company, but who cares about the process as much as you do. With the intensity of the situation a close working relationship with advisors is key...... frank and honest conversations are often required!

## Leading the way

Sheffield City Region continues to lead the way in enterprise and innovation with a series of new projects and developments being announced recently.

The internationally renowned Advanced Manufacturing Innovation District will welcome the UK Atomic Energy Authority fusion energy research centre in 2020.

The £22m investment by the UKAEA sees South Yorkshire chosen for its research expertise and its increasingly important role in the Northern Powerhouse economy.

Elsewhere in the innovation corridor, building work has been completed on Sheffield Hallam University's Advanced Wellbeing Research Centre. This sits alongside the newly opened National Centre of Excellence for Food Engineering – a multi-million-pound facility designed to improve food engineering processes and boost the competitiveness of the country's largest manufacturing sector.

Collaboration between the region's two leading universities and local businesses has been further strengthened with the Sheffield Innovation Project securing an additional £1.8m in funding.

Working with the Higher Education Innovation Fund and the European Regional Development Fund, the second stage of the project will also involve the Sheffield City Region Local Enterprise Partnership and support SMEs until 2022.

The programme assists SMEs with access to world-class facilities, academic support and workshop-based innovation guidance, and as a result we're now seeing impressive solutions to real-life business problems as well as products being brought to market.

Entrepreneurs across the region are also benefitting from a new £3m business support programme set up by the Barnsley Business and Innovation Centre, Doncaster Chamber of Commerce, East Midlands Chamber of Commerce and Sheffield Hallam University.

The European funded project – Scale Up 360 – offers tailored, high-growth business support and expertise to young people, giving them the confidence and knowledge to succeed as entrepreneurs.

In addition to the specific items mentioned above the SCR Growth Hub continues to provide support to local businesses in a number of ways.

Also in recent months, Sheffield City Council has sought £50m in government funding for a proposed Clean Air Zone to help reduce pollution from the 20 per cent of vehicles emitting 50 per cent of the city's harmful nitrogen dioxide emissions.

The plans to upgrade the most polluting vehicles to electric, hybrid or cleaner engines are the latest in a series of green schemes which are attracting international attention and putting the region on the map as a place where more and more people want to live and work.

These are just some of the latest highlights demonstrating the vision and ambition of our city region. From growth support for start-ups through to world-leading industrial-research collaborations, we're in an exciting position as we enter the new decade.
