## Graduate pathway

#### There are two options:

- The ATT/CTA Tax Pathway (similar to the nongrad route but over three years),
  or;
- The ACA/CTA (Chartered Accountant & Chartered Tax Adviser) Joint Programme
- Year 1 You will start by alternating ACA certificate and professional level exams.
- NB Where your degree gives you exemptions from any certificate or professional level exams, our study provider will ensure you have the assumed knowledge you need to complete any linked modules.
- You will also complete an ethics and professional scepticism test for ACA and an additional CTA ethics exam
- Year 2 Continuing the alternate certificate/ professional exam structure, you will start to see yourself progress in your working career.
- Year 3 You will sit two advanced level exams and two CTA exams.
- Year 4 You will sit your final ACA advanced level exam to gain the dual Chartered Accountant and Chartered Tax Adviser qualifications.
- For the ACA/CTA routes you will submit evidence of 450 days practical work experience and provide evidence of achieving professional competence to round off your training file.
