Non-graduate pathway

Y1

- Work with us while having one day a week at college working towards AAT level 3 exams.
- No need to have completed level 2; we look at UCAS points as a requirement to join us, and we have a speedy catch-up course so you feel ready to start college.

Y2

- After completing AAT level 3 you will move on to complete the ACCA Applied Knowledge stage to be awarded the ACCA Diploma in Accounting and Business.
- The only change is that there is a mix of mandatory and optional modules to tailor your study to what you are/want to be doing.

Y3

- Continuing through ACCA, you will start the Applied Skills modules.
- You will also complete an ethics and professional skills module.

Y4

- At the same time as continuing to progress your career at BHP, you will start the ACCA Strategic Professional stage of the qualification.

Y5

- In your final year of ACCA study, you will complete the last of your exams (13 in total).
- You will submit your documented three years of practical work experience to become ACCA qualified.

Graduate pathway

Y1

- ACA study is made up of certificate, professional and advanced level exams.
- You will start by alternating certificate and professional level exams to utilise the skills you learn from certificate level.
- Where your degree gives you exemptions from any certificate or professional level exams, our study provider will ensure you have the assumed knowledge you need to complete any linked modules.
- You will also complete an ethics and professional scepticism test.

Y2

- Continuing the alternate certificate/professional exam structure, you will start to see yourself progress in your working career.

Y3

- In your third and final year you will sit three advanced level exams having completed the certificate and professional levels.
- Finally, you will submit evidence of 450 days practical work experience and provide evidence of achieving professional competence to round off your training file.
